### About TheCityUK

# FOREWORD

This report examines financial and related professional services exports from each British region and nation. TheCityUK's economic research has consistently emphasised the fact that the financial and related professional services industry makes a significant contribution to the economy across the UK. One of the most visible aspects of this contribution is the industry's trade surplus in Britain, which we estimate was around £56bn in 2019. This trade surplus is based on sizable exports of financial and related professional services; the revenues from these overseas sales helps bolster the wider economy in communities across the country by diversifying industry activity and supporting job creation.

This report aims to quantify the regions' and nations' contributions to those overseas sales (using a slightly wider definition of related professional services than our usual one), providing a fuller picture of the industry's economic activity across the country. Of course, industry exports are likely to contract in 2020 as the Covid-19 pandemic wreaks havoc on the global and UK economies. However, the cyclical disruption caused by this huge exogenous shock does not alter the fact that regions and nations aside from London – especially the South East, Scotland, North West, and Yorkshire and the Humber – make large contributions to the UK's position as the world's leading financial and related professional services net exporter. This report is based on historical data through 2018, and our own estimates for industry exports in 2019. As such, it does not assess the impact of the pandemic on regional trade – something that will be covered in future research, when the extent of the impact is clearer.

For the first time, however, we have included new analysis on the destination of industry exports. We continue to engage with the Office for National Statistics (ONS) as they refine the quality and quantity of their sub-national economic statistics, and commend them for the significant work they have done – and continue to undertake – to expand the range of data available.

## INTRODUCTION: BRITISH FINANCIAL AND Related professional services exports

In 2019 financial and related professional services exports across Britain rose by 8.2% to £126.5bn (Figure 1).<sup>1</sup> All regions and nations in Britain saw growth in financial and related professional services exports in 2019, according to our estimates.



Yorkshire and the Humber experienced the strongest annual average growth of financial and related professional services exports over 2014-18, at 17%. It was followed by the East Midlands (15%), London (9%), the North East and Scotland (8% each). Meanwhile, the East of England experienced no growth in industry exports, and average annual growth in Wales and the South East was merely 1% during that period (Figure 2).






In this report, financial services includes financial and insurance services. Related professional services includes accountancy, legal services, and management consultancy and business management. This last category is wider than TheCityUK's normal definition of related professional services, but has been included here as the ONS does not separate business management from management consultancy in its services export data.

As the world's leading international financial and related professional services hub, London unsurprisingly dominates the British financial and related professional services exports market. However, around half of industry exports came from outside London in both 2018 and 2019. The South East was the largest exporter outside the capital in 2019, followed by Scotland and then the North West (see Figure 1). To put this in an international context, in 2019 Scotland's financial services exports were equivalent to around 50% of those of the whole of France, and the North West's financial services exports was equivalent to around 45% of French financial services exports, according to TheCityUK calculations based on data from UNCTAD and the ONS. This reflects the fact that the UK as a whole is the world's second-largest exporter of financial services, after the US.

Financial services was the biggest exporting service sector in every British region and nation in 2018 apart from the South East (where the largest exporting service sectors in that year were professional, scientific and technical activities and

Information and communication services) and the East of England (where the largest exporting service sector in that year was professional, scientific and technical activities). Financial and related professional services exports as a percentage of total services exports in 2018 varied from 22% in the East of England to 52% in Yorkshire and the Humber.

The chart below shows each region's total services exports alongside its financial and related professional services exports, to put the latter in context. Looking at financial and related professional services exports as percentage of total services exports, industry exports in Yorkshire and the Humber accounted for 52% of the total in 2018, followed by London (46%), the South West (43%), Scotland (40%), and the North West (38%).

In about half the regions and nations in Britain, relative shares of financial services exports and related professional services exports are quite balanced. In the North East, North West, Scotland, the West Midlands, and Yorkshire and the Humber, however, the regions' financial services exports as a percentage of Britain's financial services exports was around double the comparable percentage for related professional services; in the South East, by contrast, related professional services exports was almost double the comparable percentage of British sector exports was almost double the comparable percentage for financial services.

All regions and nations in Britain have trade surpluses in financial services (because exports exceed imports). London had the largest financial services trade surplus of £29.1bn in 2018, followed by Scotland (£4.6bn) and the North West (£4bn). The North East has the lowest trade surplus (£600m), followed by Wales (£1.4bn) and the East Midlands (£1.5bn); for more information see Figure 4.

Considering an even more detailed geographical breakdown, financial services were an important category of service exports for the various city regions, making up more than 30% of service exports in 11 of the 15 city regions analysed.<sup>2</sup> (The city regions include 10 English city regions and combined authorities, plus the local regions of Aberdeen; Cardiff; Edinburgh and South-east Scotland; Glasgow; and Swansea Bay.) Professional, scientific and technical services, the broader category which includes legal, accounting, management consulting and business services, also made a significant contribution to services exports in some city regions, notably the Cambridgeshire and Peterborough Combined Authority, where the category accounted for 41% of total services exports, and Aberdeen City Region, where it represented 28% of services exports (Figure 5).

In terms of the destination of industry exports, 36% of British financial services exports went to the EU in 2018, and the remaining 64% went to non-EU countries. The regional variation of financial services exports destination is minimal. Individual regions' share of financial services exports going to the EU ranged from 33% to 42%. The regional range of exports going to non-EU countries ranged from 58% to 67%. A more detailed geographical breakdown of export destinations is not available on a regionalised basis, but for the UK as a whole, the US was by far the largest destination for financial services exports, accounting for 29.8% of total financial services exports in 2018. Other notable non-EU destinations for industry exports were Japan (4.8%) and Canada (3%).

# EAST MIDLANDS

The East Midlands exported £3.7bn of financial and related professional services in 2019, up 15.7% from 2018, according to TheCityUK estimates. According to ONS data, financial services exports from the East Midlands accounted for 2.9% of Great Britain's total financial services exports in 2018, and TheCityUK estimates related professional services exports from the region accounted for 2.1% of Great Britain's total related professional services exports. Forty-two percent of the East Midlands' financial services exports went to the EU in 2018, and the remaining 58% went to the rest of the world.



# EAST OF ENGLAND

The East of England exported £4.2bn of financial and related professional services in 2019, up 0.8% from 2018, according to TheCityUK estimates. According to ONS data, financial services exports from the East of England accounted for 3.3% of Great Britain's total financial services exports in 2018. TheCityUK estimates related professional services exports from the region accounted for 4.4% of Great Britain's total related professional services exports. Thirty-five percent of East of England's financial services exports went to the EU in 2018, and the remaining 65% went to the rest of the world.




### Figure 14: Financial services exports from sub-regions (NUTS2) in the East of England, 2018

# LONDON

London exported £66.1bn of financial and related professional services in 2019, up 9% from 2018, according to TheCityUK estimates. According to ONS data, financial services exports from London accounted for 49.7% of Great Britain's total financial services exports in 2018. TheCityUK estimates related professional services exports from the region accounted for 59.9% of Great Britain's total related professional services exports. Thirty-three percent of London's financial services exports went to the EU in 2018, and the remaining 67% went to the rest of the world.




### Figure 18: Financial services exports from sub-regions (NUTS2) in London, 2018

# NORTH EAST

The North East exported £2.2bn of financial and related professional services in 2019, up 8.1% from 2018, according to TheCityUK estimates. According to ONS data, financial services exports from the North East accounted for 1.9% of Great Britain's total financial services exports in 2018. TheCityUK estimates related professional services exports from the region accounted for 1.1% of Great Britain's total related professional services exports. Thirty-nine percent of North East's financial services exports went to the EU in 2018, and the remaining 61% went to the rest of the world.




### Figure 22: Financial services exports from sub-regions (NUTS2) in the North East, 2018

# NORTH WEST

The North West exported £8.4bn of financial and related professional services in 2019, up 7.3% from 2018, according to TheCityUK estimates. According to ONS data, financial services exports from the North West accounted for 7.4% of Great Britain's total financial services exports in 2018. TheCityUK estimates related professional services exports from the region accounted for 3.8% of Great Britain's total related professional services exports. Forty-one percent of North West's financial services exports went to the EU in 2018, and the remaining 59% went to the rest of the world.



# SCOTLAND

Scotland exported £9.2bn of financial and related professional services in 2019, up 7.7% from 2018, according to TheCityUK estimates. According to ONS data, financial services exports from Scotland accounted for 8.2% of Great Britain's total financial services exports in 2018. TheCityUK estimates related professional services exports from the nation accounted for 3.9% of Great Britain's total related professional services exports. Thirty-seven percent of Scottish financial services exports went to the EU in 2018, and the remaining 63% went to the rest of the world.



### Figure 26: Financial services exports from sub-regions (NUTS2) in Scotland, 2018






### Figure 34: Financial services exports from sub-regions (NUTS2) in the South East, 2018






Figure 39: Welsh financial and related professional services exports, £m




### Figure 42: Financial services exports from sub-regions (NUTS2) in Wales, 2018



Forty-two percent of Yorkshire and the Humber's financial services exports went to the EU in 2018, and the remaining 58% went to the rest of the world.

#### Figure 47: Yorkshire and the Humber financial and related professional services exports, £m





Figure 48: Financial and related professional services exports from Yorkshire and the Humber, £m



# CONCLUSION

As the UK's largest financial and related professional services centre and the world's leading international hub for such services, London inevitably leads the UK's exports of these services. But the idea that London sells financial and related professional services overseas and the rest of the UK focuses on domestic activity is misleading. As this report shows, other regions, especially the South East, Scotland, North West and Yorkshire and the Humber also make important contributions to exports of financial and related professional services. Around half of financial and related professional services exports came from outside London in 2018 and, based on our estimates, in 2019. Although it is too soon to tell how extensive the negative impact of Covid-19 will have been on financial and related professional services exports in 2020, the very widespread nature of the pandemic – affecting almost all countries globally, and nearly all industries in some shape or form – means that we would expect to see more change in the overall volume of industry exports than in the various regional contributions. The pandemic and the policy measures designed to address the public-health crisis have triggered an enormous shock to the economies of the UK as well as its major trading partners. Supportive government policies have mitigated the worst effects of the crisis, and it is imperative that policy continues to ensure the best possible business environment in the UK, so that British exporters – in all the regions and nations – can be best-placed to capitalise on the eventual return to global growth.
