FOREWORD

This report examines financial and related professional services exports from each British region and nation. TheCityUK's economic research has consistently emphasised the fact that the financial and related professional services industry makes a significant contribution to the economy across the UK. One of the most visible aspects of this contribution is the industry's trade surplus of around £75bn in 2017.

However, this reports aims to quantify the regions' and nations' contributions to those overseas sales, providing a fuller picture of the industry's economic activity across our country. As the world's leading international financial and related professional services hub, London accounts for just over half of such exports – but other regions, especially the South East, Scotland, North West and the West Midlands make large contributions.

This year, I am very pleased that we have been able to analyse, for the first time, industry exports at an even finer level of geographical detail: the major sub-regions (for example, the English counties) and also the 15 joint authorities that encompass Britain's largest cities. We continue to engage with the Office for National Statistics (ONS) as they refine the quality and quantity of their sub-national economic statistics, and commend them for the significant work they have done – and continue to undertake – to expand the range of data available

BRITISH FINANCIAL AND RELATED PROFESSIONAL SERVICES EXPORTS

In 2017 financial and related professional services exports across Britain rose by 3% to £96.9bn (Figure 1). All regions and nations in Britain saw growth in financial and related professional services exports in 2017, according to our estimates. Scottish and Welsh financial and related professional services exports experienced the strongest growth among all regions and nations in Britain during the period 2012-16, with average annual growth of 7%.



Industry exports have been volatile in recent years. After a two-year contraction in financial and related professional services exports in 2013 and 2014, industry exports experienced strong growth of 7% in 2015 and 10% in 2016 (Figure 2). In addition, there is considerable inter-regional variation in performance. The North East, East of England and the East Midlands experienced the most volatile rates of growth in industry exports over the 2012-16, while growth rates in the South East, Yorkshire and the Humber, and the North West were relatively steady.

In this report financial services includes financial and insurance services. Related professional services includes accountancy, legal services, and management consultancy and business management. This last category is wider than TheCityUK's normal definition of related professional services, but has been included here as the ONS does not separate business management from management consultancy in its services export data.

As the world's leading international financial and related professional services hub, London unsurprisingly dominates the British financial and related professional services exports market. However, around half of industry exports came from outside London in both 2016 and 2017. The South East was the largest exporter outside the capital in 2017, followed by Scotland and then the North West (see Figure 1). To put this in an international context, in 2017 the North West's financial services exports were equivalent to almost 40% of those of the whole of France, and the South East's financial services exports were equivalent to over 50% of French financial services exports, according to TheCityUK calculations based on data from UNCTAD and the ONS. This reflects the fact that the UK as a whole is the world's second-largest exporter of financial services, after the US.

Financial services was the biggest exporting service sector in every British region and nation in 2016 apart from the South East (where the largest exporting service sector in that year was real estate, professional, scientific and technical services). Financial and related professional services exports as a percentage of total services exports in 2016 varied from



27% in the South East to 50% in Wales (Figure 4). Considering a more detailed geographical breakdown, the ONS notes that 'Financial services were an important category of service exports for the joint authorities, making up more than 18% of service exports in 12 of the 15 joint authorities analysed.' (The joint authorities are: the seven English Combined Authorities; Greater London; Mayoral authority of Sheffield City Region; Cardiff Capital Region; Swansea Bay City Region; Glasgow City Region; Aberdeen City Region; and Edinburgh and South East Scotland City Region.) Real estate, professional, scientific and technical services, the broader category which includes legal, accounting, management consulting and business services, also made a significant contribution to services exports in some joint authorities, notably Aberdeen City Region, where the category accounted for 49.2% of total services exports, and Cambridgeshire & Peterborough Combined Authority, where it represented 30.7% of services exports (Figure 3).

The table below shows total goods exports as well as total services exports alongside the financial and related professional services proportion of services exports to provide additional context. Looking at financial and related professional services exports as percentage of total exports (goods plus services), industry exports in London accounted for 32% of the total. In Yorkshire and the Humber and Scotland the figure was 16% each, and 14% each in the South West and Wales in 2016. Outside London, the percentages of total exports varied from 8% in the East Midlands to 16% in Yorkshire and the Humber and Scotland.

In about half the regions and nations in Britain, relative shares of financial services exports and related professional services exports are quite balanced. In the North West, Scotland, Wales, the West Midlands, and Yorkshire and the Humber, however, the regions' financial services exports as a percentage of Britain's financial services exports was around double the comparable percentage for related professional services; in the South East, by contrast, related professional services exports as a percentage of British sector exports was almost double the comparable percentage for financial services.

ONS data released for the first time in February 2019 now allows us to analyse financial services exports at a sub-regional (NUTS2) level.⁴ Out of the 40 sub-regions in Great Britain there are 15 (38%), which have at least £1bn financial services exports (Figure 5) and a total of 28 (70%) with £500m or more in financial services exports.⁵

The East Midlands exported £2bn of financial and related professional services in 2017, up 4.3% from 2016, according to TheCityUK estimates. According to ONS data, financial services exports from the East Midlands accounted for 2.1% of Great Britain's total financial services exports in 2016, and related professional services exports from the region accounted for 2.2% of Great Britain's total related professional services exports.

Figure 6: Financial and related professional services exports from the East Midlands, £m






Figure 7: Detailed breakdown of financial and related professional services exports from the East Midlands, £m

Figure 9: Financial and related professional services exports from the East of England, £m






Figure 10: Detailed breakdown of financial and related professional services exports from the East of England, £m

Figure 12: Financial and related professional services exports from London, £m






Figure 13: Detailed breakdown of financial and related professional services exports from London, £m


Figure 14: Financial services exports from sub-regions in London, 2016

Figure 15: Financial and related professional services exports from the North East, £m






Figure 16: Detailed breakdown of financial and related professional services exports from the North East, £m

Figure 18: Financial and related professional services exports from the North West, £m






Figure 19: Detailed breakdown of financial and related professional services exports from the North West, £m

Figure 21: Financial and related professional services exports from Scotland, £m






Figure 22: Detailed breakdown of financial and related professional services exports from Scotland, £m

Figure 24: Financial and related professional services exports from the South East, £m






Figure 25: Detailed breakdown of financial and related professional services exports from the South East, £m

Figure 27: Financial and related professional services exports from the South West, £m






Figure 28: Detailed breakdown of financial and related professional services exports from the South West, £m

Figure 30: Financial and related professional services exports from Wales, £m






Figure 31: Detailed breakdown of financial and related professional services exports from Wales, £m

Figure 33: Financial and related professional services exports from the West Midlands, £m






Figure 34: Detailed breakdown of financial and related professional services exports from the West Midlands, £m

Figure 36: Financial and related professional services exports from Yorkshire and the Humber, £m






Figure 37: Detailed breakdown of financial and related professional services exports from Yorkshire and the Humber, £m

CONCLUSION

As the UK's largest financial and related professional services centre and the world's leading international hub for such services, London inevitably leads the UK's exports of these services. But the idea that London sells financial and related professional services overseas and the rest of the UK focuses on domestic activity is misleading. As this report shows, other regions, especially the South East, Scotland, North West and West Midlands also make important contributions to exports of financial and related professional services. Around half of financial and related professional services exports came from outside London in 2016 and, based on our estimates, in 2017.

Supportive government policies can help foster an environment in which Britain's exporting firms can continue to thrive. But government policy will be most effective if it is based on accurate and timely indicators of local business and economic conditions. Because of this, TheCityUK is extremely supportive of work the ONS has already done to expand its regional data offerings, and looks forward to continued progress in this area. We will continue to engage with the ONS in support of this objective and with a view to helping to further develop data for financial and related professional services in particular.
